#### Back to in-person internships

We were grateful to have thirtyseven law firms and law related partner with Project businesses Youth OC's Project SELF program which provided **47** high school students with law related internship placements. Our students had work experience summer opportunities that included exposure to professional work environments, meaningful career exploration, relationships with professional mentors, and a field trip to Chapman Law School.



At the conclusion of the eight-week internship we celebrated our interns by hosting a recognition reception which included college scholarships for selected students.

#### Interview with Claudia on her Project Self Experience

#### Why did you participate in Project SELF?

I was encouraged to apply by my English teacher. He believed I had great writing skills that would lead me to many potential career choices. He especially thought I would benefit from the Project SELF program that could lead me to consider law school.

#### Who influenced you most during your internship?

Dora Moran who was my Supervisor at the records department at Gibson Dunn. She was always so encouraging with every project I was assigned. She pushed me to do better and rewarded my hard work. She was incredibly compassionate and caring, which I really appreciated.

#### How did Project SELF prepare you for what you are doing today?

It provided a lot of insight into what I do now, practice law. Most importantly, however, it taught me the value of support staff. I went from a Project SELF intern to a Records Clerk to Project Assistant to Paralegal. I climbed the ladder appreciating what each job does to support attorneys. I can also do a lot of that work for myself now that I am a lawyer.

#### What advice would you give a current Project SELF intern or recent Project SELF participant?

Do your best, put your best foot forward and show people that you gave it your all. Not only does this make a good impression, but it lets you grow as a person. Keep in touch with anyone you connected with, and if you're remotely interested in law, pursue that interest until you decide if it's for you. Whether or not you end up in law school, you'll be a better person for your efforts, you'll learn more about yourself along the way.

#### Share your best Project SELF memory.

Speaking with the attorneys about their cases, watching the amount of work they had to do in preparation for trial...I found it to be very fascinating. Reading the pleadings and motions was like reading books which took me to places and circumstances I only imagined existed in movies.
